CPRE Hertfordshire supports the principles of this Policy but suggests that to be consistent with other policies in the Plan the site size criterion should be amended to encourage the optimal use of sites, particularly for smaller dwellings, through either reducing the qualifying site size to 0.75 hectares, or increasing the number of dwellings to 15.

Similarly the policy should require the impact on the Green Belt to be 'minimal', rather than 'limited'. There should be a requirement that this minimal impact is demonstrated in a Planning Statement accompanying the planning application.
