No exceptional circumstances for the removal from the Green Belt of the proposed housing site (HS24) for 100 dwellings on the western edge of Little Heath have been set out by the Council, contrary to national planning policy (NPPF paragraph 83).

Development of this site would have an adverse impact on four of the stated purposes of the Green Belt, and is totally out of scale with the small settlement of Little Heath, which currently maintains its separate identity from the town of Potters Bar to the south.

CPRE Hertfordshire particularly objects to the removal of this site from the Green Belt because this action threatens the integrity of adjacent Green Belt land immediately to the south, on the edge of Potters Bar in Hertsmere Borough, and which would be surrounded on three sides by development if the proposal was implemented as intended by the Council.

The visual separation of Little Heath and Swanley Bar would also be adversely affected, exacerbated by the merging of Little Heath with the currently separate residential enclave north of Hawkshead Road.

The proposal is therefore unsound for the above reasons, and in that it is unjustified by any evidence presented by the Council.
