No exceptional circumstances for the removal of the proposed housing site (HS22) for 250 dwellings from the Green Belt west of Brookmans Park have been set out by the Council, contrary to national planning policy (NPPF paragraph 83).

Development of this site would have a major adverse impact on the stated purposes of the Green Belt, in particular causing significant encroachment of built development into the countryside. The proposal is therefore unsound, in that it is unjustified by the evidence presented by the Council, and because it is based on an excessive housing target for the Borough, as explained in our representations on Policy SP 2, as well as being in conflict with Green Belt policy set out in the NPPF.
