Policy SP 19 proposes the creation of a major urban extension to the south east of Welwyn Garden City that would extend into the adjacent district of East Hertfordshire, and include the construction of 2,550 dwellings, of which 1,200 would be in Welwyn Hatfield. All of the land covered by the proposal lies within the Green Belt as defined in the extant Local Plans of the two local planning authorities.

CPRE Hertfordshire considers that this proposal is unsound by virtue of being both unjustified and inconsistent with the policies set out in the NPPF, and in particular paragraphs 14 (on Sustainable development and local planmaking), and 79 to 81 and 83 to 84 (on Green Belt).
