Dear Town Councillors,

## **Dacorum Local Plan Consultation – Emerging Strategy for Growth**

Having now had an opportunity to review the lengthy Dacorum Borough Council Emerging Strategy for Growth (2020-2038) and the associated reports, CPRE Hertfordshire has serious concerns regarding the massive scale of proposed development in the countryside and the impact this will have on the Green Belt, Chilterns AONB, chalk streams, climate change and biodiversity. Although some settlements will be more directly affected than others, it is obvious that the overall impact on the environment and infrastructure, including traffic congestion, water supply and waste water disposal, will be felt across the whole borough and beyond.

The Strategy proposes the building of 16,899 dwellings (dw) including approx. **10,000 dwellings in the Green Belt**. Sites include land at Berkhamsted (1750 dw), Tring (2250dw) and north of Hemel Hempstead (1500dw) plus a safeguarded site for a further 4,000 dw beyond the plan period. Green Belt is also under threat at Kings Langley (145dw), Bovingdon (150dw) and Markyate (150dw). Along with several proposed greenfield employment sites, we estimate that a massive 850 hectares of countryside and green space could be lost to development. This is equivalent of 1,214 football pitches.

I attach our own 2-page analysis of sites for your assistance as we have not been able to find this information in one place in the on-line documents provided by Dacorum BC.

I also attach a summary of CPRE Hertfordshire's Key Concerns pending a more detailed analysis as we prepare our formal response in the coming weeks. Please visit our website for more detailed commentary on these Key Concerns.

If you share our concerns, we urge your council to respond to the consultation and to lobby local politicians and MPs to ensure that local voices are heard in order to help shape the next, pre-submission, stage of the Local Plan. We know that many of our CPRE members in Dacorum are very worried by the apparent pursuit of growth over environmental issues.
