Whilst we recognise that these two locations in the Green Belt referred to in the Policy are primarily previously developed sites, we strongly oppose the support given by the Policy for their possible future extension further into the Green Belt. Such support is contrary to national Green Belt policy, and by definition is not justified by the existence of very special circumstances at the present time.

We note that there is currently no reference to relevant Green Belt constraints in the sections of the Policy for either site, which we consider to be unsound.

CPRE Hertfordshire therefore seeks the removal of any reference to expansion of either site beyond that defined on the Policies Map, and a statement included in the Policy that very special circumstances will need to be demonstrated for any development at the site that would result in the reduction in the openness of the Green Belt in accordance with paragraph 145 of the NPPF.
