Whilst supporting the sentiments expressed in the main sections of this Policy, CPRE Hertfordshire has concerns and objections to some of the content as follows:

- Bullet point 4 on management of the Green Belt seeks use for recreational purposes, but this should be subject to a caveat limiting such development to 'open' and such other uses that do not require major built development that would adversely affect the openness of the Green Belt, one of its two key characteristics as defined by national Planning policy.
- 2) CPRE Hertfordshire strongly objects to the wording of paragraphs 4 and 5 of the Policy, which proposes construction of schools (categorised as inappropriate development in the Green Belt by national policy), without the demonstration that exceptional circumstances exist for them to be removed from the Green Belt. The bald statement that such development within the sites remaining in the Green Belt 'is considered in principle to demonstrate very special circumstances' is not consistent with national Green Belt policy.
- 3) CPRE Hertfordshire has similar concerns about paragraph 6 of the Policy in respect of transport infrastructure, which should also be demonstrated to be either 'appropriate' in the Green Belt, or that very special circumstances actually exist for such development, rather than a simple assertion.
