CPRE Hertfordshire objects to Policy S6 for the designation of 11 Broad Locations for a range of categories of inappropriate development in the current Green Belt and for their removal from the Green Belt. Some of the locations include proposals for secondary schools which are inappropriate development, as pointed out in our representations on Policy S3. Others include major transport infrastructure that may also be inappropriate, but on which limited information exists at present, as noted in our representations on the Policies Map.

All of the individual locations listed in the Policy are unsound because exceptional circumstances for their removal from the Green Belt have not been demonstrated by the Council in the context of the latest relevant information on housing need and supply and paragraph 11 of the new NPPF. In the absence of any comparative assessment of the 10 individual locations proposed for housing development on the Green Belt, and the reduced need and demand for housing revealed by the 2016-based household projections of some 3,400 dwellings during the Plan period, all of which the Plan states should be built in the Green Belt broad locations, such exceptional circumstances have not been demonstrated.

Policy S6 (ii) relates to a 55 hectare 'Broad Location' in the Green Belt for employment land east of Hemel Hempstead, which has similarly not been justified by exceptional circumstances, and is also inconsistent with national planning policy, as noted in our representation on Policy S5.

Please see also our representations on Policies S2 (development strategy) and S4 (housing target), the latter of which set out the relevant provisions of paragraph 11 of the NPPF that should underpin proposals for development in the Plan.
