Planning application no. 24/02949/FUL

Land in Rucklers Lane, Kings Langley

Material change of use to a residential caravan site, for occupation by Gypsies/Travellers, comprising the siting of 2 static caravans and associated hardstanding

I write with regard to the above planning application to which CPRE Hertfordshire objects for the following reasons.

- The land identified for this proposed development is designated as London Metropolitan Green Belt where development is inappropriate unless very special circumstances are identified which clearly outweigh the harms caused, according to criteria in the National Planning Policy Framework (NPPF). No such circumstances have been identified in this application and the information submitted is entirely inadequate to be able to make an informed response.
- 2. At the very least, due to the importance of planning issues on designated protected land, a Planning Statement should be presented to provide a justification for the proposed development. Notwithstanding this lack of information, any proposed development in this location will impact considerably on the Green Belt and this is exacerbated by the identification of part of the site as Ancient Woodland.
- 3. CPRE Hertfordshire supports fully the objections and concerns of the Woodland Trust and the very extensive local community responses regarding the potential impact of the proposal on the rural character and amenity of the area. It is clear that any development, including concrete hard-standings, would be seriously damaging and lead to continued deterioration in the quality of the Green Belt in this location.
