TO NOTE:

Local Government Reorganisation

All 10 districts and Hertfordshire County Council are subject to Local Government Reorganisation and will be restructured into new unitary authorities. <https://www.gov.uk/government/collections/hertfordshire-local-government-reorganisation> It is not yet clear how and when these changes will impact adopted and emerging Local Plans and the Joint Strategic Plans listed below.

Legacy Local Plans and New Local Plans

In March 2026, the Government introduced new procedures for making Local Plans. Some councils have already started work on their ‘new’ local plan which must be completed within 30 months. Some of these councils have not yet adopted their current emerging Local Plan and are therefore running both ‘legacy’ and ‘new’ emerging plans. Local Plans are likely to be subject to further change when the Local Government Reorganisation is complete.

Examination: Public hearing held by independent Planning Inspector to assess merits of Submitted Local Plan policies and their soundness.
